1.0 ROLE OF DEPARTMENT OF BIOTECHNOLOGY, NEW DELHI

- 4.1 All the assets including the equipment and produce acquired will be the property of DBT and shall not be utilized for purposes other than teaching/capacity building at Guru Nanak College Budhlada. The rights of DBT under this MoA shall not be transferred to any other party without prior approval in writing of DBT.
- 4.2 It shall be the responsibility of Guru Nanak College Budhlada to ensure that support of DBT is suitably acknowledged in the publications (papers, reports, etc.) arising out of the programme.

5. MONITORING

- 5.1 The progress of implementation of the programme and proper utilization of grant shall be reviewed by the DBT and by the Advisory Committee set up by Guru Nanak College Budhlada. The periodic progress of physical achievements and the utilization of funds, statement of expenditure shall be evaluated by the Advisory Committee & DBT-UGC Task Force on HRD.
- 5.3 The Comptroller and Auditor General of India, at his discretion shall have the right of access to the books and accounts of Guru Nanak College Budhlada for the grants received from DBT for this programme
- 5.4 The DBT may terminate the grant at any stage if it is convinced that the grant has not been properly utilized or appropriate progress has not been made. In the event, DBT terminates the grant Guru Nanak College Budhlada shall hand over all documents including technical details and equipment purchased related to the programme.

1. 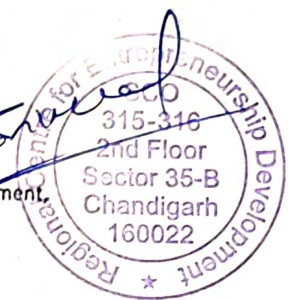

MEMORANDUM OF UNDERSTANDING

This Memorandum of Agreement between the Indian Institute of Food Processing Technology (IIFPT), Thanjavur and Guru Nanak College, Budhlada, is intended to facilitate a collaborative program of research, skill development, consultancy, institutional development, information dissemination and students in-plant training. The linkage hereby formed shall further strengthen each partner institution's objectives as well as the mutual relationship between the partners.

About Indian Institute of Food Processing Technology (IIFPT)

Indian Institute of Food Processing Technology is a reputed R&D and educational institution under the Ministry of Food Processing Industries, Government of India. IIFPT offers B. Tech, M. Tech, and Ph. D programs in Food Process Engineering, M. Tech in Food Science and Technology and PhD in Biotechnology. IIFPT has international standard laboratories including: NABL accredited Food Quality and Safety Testing Laboratory which is also FSSAI referral lab; ISO 9000, 14000 and 22000 Certified Food Processing Business Incubation cum Training Centre; AICTE approved Teaching Laboratories and State-of-Art Hi-Tech Food Processing Research Laboratories. The facilities available at IIFPT are effectively explored through offering hands-on trainings, consultancy services, incubation services, quality testing and R&D support for food industry stakeholders. The college has consistently been enlightening its glory in the state and of course nationally. Guru Nanak College, affiliated to Punjabi University, Patiala (listed in 12(b) & 2(f) sections of UGC Act 1956) is situated in outskirts of Budhlada city - a small town of district Mansa in Punjab. To tribute the 500th birth anniversary of "Sri Guru Nanak Dev Ji", it was started in 1971 by some eminent personalities of the region keeping in mind the noble cause to make affordable education accessible to all the people of this backward, rural and remote area. In the beginning, it was functioning under the local management but later on handed over to SGPC (Shiromani Gurdwara Parbandhak Committee, Sri Amritsar Sahib) an apex and philanthropic body of the Sikhs committed to serve the humanity, on 09 November 1994 due to meager financial resources and some other executive problems. It was followed by some significant reforms in both college functioning and infrastructure.

5. Exchange of documentation and research materials in fields of mutual interest provided that, to the best knowledge of the respective institutions, there is no prohibition at law or otherwise against the exchange; and,

whereas

- A. Details of the implementation of any particular student or faculty-related activity resulting from this Memorandum of Understanding shall be negotiated between the two institutions as such specific case may arise and will be outlined in a Supplementary Student Research Agreement or Faculty Research Agreement between the institutions. Supplementary Agreements are subject always to availability of sufficient funds to the respective institutions.
- B. This Memorandum of Understanding reflects the respective institutions' commitments to both educational and research exchanges as of the date of the Memorandum of Understanding. This Memorandum of Understanding may be amended or terminated at any time by either party provided that notice of termination or amendment is provided by the notifying party to the other party within thirty (30) days of the date on which the termination or the amendment is intended to become effective. Any amendment or termination shall not have effect on any arrangement in place at the time that the notice is provided, where the arrangement arises from any Supplementary Agreements resulting from this Memorandum of Understanding.

Both institutions subscribe to the policy of equal opportunity and will not discriminate on the basis of gender, age, disability, race, color, religion, marital status, veteran's status, national or ethnic origin, or sexual orientation.

This Memorandum of understanding will become effective immediately. It shall continue in effect for a period of five years and may be extended by mutual agreement. It may be terminated by either institution upon one-year written notification to the partner institution.



MEMORANDUM OF UNDERSTANDING

This MEMORANDUM OF UNDERSTANDING (MOU) is made on 29th Day of June 2020 at New Delhi

BETWEEN

Guru Nanak College affiliated to **Punjabi University Patiala** having its campus at Jakhal- Bareta Road, Budhlada (Mansa) (hereinafter called as "GNC Budhlada" which expression shall where the context so admits, include its successors, permitted assigns will include its constituents) of the ONE PART.

AND

Food Industry Capacity & Skill Initiative, registered under the Societies Registration Act, 1860 having its office at 601, 6th floor, Mercantile House, Kasturba Gandhi Marg, Connaught Place, New Delhi – 110001, (hereinafter referred as "FICSI" which expression shall, unless repugnant to the context or meaning thereof, be deemed to mean and include its successors and assigns) on the OTHER PART

Guru Nanak College, Budhlada and FICSI shall hereafter be collectively referred to as "Parties" and reference to "Party" shall mean FICSI or Guru Nanak College as the case may be.

WHEREAS:

Guru Nanak College located at Jakhal- Bareta Road, Budhlada (Mansa) and under Punjabi University, Patiala recognized under 12(b) & 2(f) Sections of the UGC Act 1956. The college strives to impart skill based quality education and promote research driven advancement of knowledge for creating successful professionals.

Food Industry Capacity & Skill Initiative (FICSI) is the Sector Skill Council for the "Food Processing" Sector and has been formed under the aegis of the National Skill Development Council (NSDC) and Federation of Chambers of Commerce of India (FICCI) as an initiative to promote skill development. FICSI functions as an autonomous body and its main charter/objectives are as under:

- Identify the skill development needs of the "Food Processing" Industry.
- Set National Occupational Standards (NOS).
- Approve curriculum for training.
- Execute "Train the Trainer" programmes.
- Accredite Training Institutes imparting training in "Food Processing" related job roles.
- Set assessment and certification processes.
- Establish Labour Market Information System (LMIS).
- Undertake research to identify future needs.

This MoU is intended to outline the general framework for collaboration between the Parties for running skill based program in food processing in various subsectors of food processing for creating trained manpower specially for MSME as well as for startups and Entrepreneurship. The initial goal of this memorandum of understanding is to outline and describe certain of the respective goals, strategies and



objectives, as the case may be, as well as the intent of the parties to conduct collaborative activities to establish and promote a mutually beneficial relationship. As such, the actual details of each specific collaboration and/or transaction will be determined by mutual agreement of Parties.

BOTH PARTIES mutually agree to conduct the following activities:

A. Training programme as per National Skill Qualification Framework (NSQF)

Guru Nanak College, Budhlada will impart skilling in Food Processing based on FICSI's Qualification Pack (QP) as part of the the course curriculum for the students. In this regard, college must have UGC approval to start the course.

B. Assessment & Certification

FICSI will conduct Assessment & certification of students trained under different skill based training programs of Guru Nanak College, Budhlada aligned to FICSI QPs.

C. Train the Trainer

FICSI would organize 'Train the trainers' programme on the QPs developed by FICSI in collaboration with the institute.

D. Development of Occupational Standards, Curriculum, Learning materials

FICSI is involved in the development of National Occupational standards, Qualification Packs, Curriculum & Course Content for the various segments of Food Processing. It may support the institute in development of course curriculum related to skill based program in food processing as per guideline and institute will also support FICSI with its technical expertise to develop and validate QP, curriculum and course content.

E. Collaborative Efforts for furthering in skilling

Institute will teach NSQF aligned job roles under the skill component and this will include on-the-Job training/ Apprenticeship / practical classes in laboratories / workshops/ internship which will give candidate a better exposure in the job market. FICSI has already developed a job portal for such candidates where candidates' information can be shared with the industry for placement purpose. (College name) will share the information of eligible students to feed into the job portal.

F. Manpower & Infrastructure required

The existing infrastructure and manpower of the Parties will be used for the implementation of the collaborative activities to the extent agreed by each party. Within 30 days both Parties will nominate a Liaison Officer for coordinating the collaborative activities.

H. Duration of MoU

This memorandum of understanding shall be deemed to have come into force w.e.f the date of signing and shall remain in force for 3 years.

I. Entire agreement

This MoU shall constitute of the entire understanding between the Parties with respect to the subject matter hereof and supersede all prior agreements or understandings of the Parties relating thereto.



J. Amendments

No modifications or amendments of any terms or conditions of this understanding shall be effective unless made in writing and signed by the authorized representatives of the parties.

K. Arbitration / Dispute Settlement

In case of any dispute that may arise during or after project execution, the matter would be settled mutually.

L. Notices

All notices required or permitted by, or made pursuant to this MoU shall be in writing and sent by registered post to the following address:

For Guru Nanak College, Budhlada:

M. Implementation

The parties shall review the Implementation and the application of this MoU through a joint committee in every 3 months alternatively. This Implementation Committee shall meet as required at either of parties work places.

N. Assignment

This MoU is based on the professional competence and expertise of each party and hence neither party shall transfer or assign this MoU or rights or obligations arising hereunder, either wholly or in part, to any third party.

N. General Provisions

1. The parties shall bear their respective costs of carrying out the collaborative activities envisaged under this MoU. Neither party shall make a claim against the other party for any expenditure, unless such expenditure has been agreed upon in writing between the parties.

2. Either party reserves the right to terminate this MoU subject to 60 days prior written notice to the other party hereto. Any program or activity that was already commenced shall survive the termination of this MoU and be completed to the best of both parties abilities pursuant and subject to the terms of this MoU.

O. Non - exclusivity

The relationship of the parties under this MoU shall be non - exclusive and both parties are free to pursue other agreement or collaboration of any kind. However, when entering into a particular research agreement which may have some elements of existing FICSI - Guru Nanak College, Budhlada collaboration, then the participants may agree limit each party's right to the collaborate with other on that subject.

This MoU has been executed in two originals, one of which has been retained by Guru Nanak College, Budhlada and other by FICSI.

This Memorandum of Understanding (MoU) has been made and agreed upon between the Parties mentioned below, signed on 18 July, 2022

BETWEEN

National Association of Software and Service Companies (NASSCOM) having its head office at the NASSCOM Plots 7-10, Sector 126, Noida, UP – 201303, India (hereinafter called “NASSCOM”), represented by the Executive Director IT-ITeS Sector Skills Council NASSCOM, which expression shall, where the context so admits, be deemed to include its successors, executors and administrators of the ONE PART

AND

Narinder Singh, Nodal Officer, represented by the **Guru Nanak College, Budhlada** (hereinafter referred to as “Second Party”) which expression shall unless repugnant to the context or meaning thereof, include its successor in office, legal representatives and permitted assigns of the SECOND PART

Background and Purpose

Guru Nanak College, Budhlada has been established in the state of **Punjab** for skilling youth to carry forward the skill development initiatives in a co-ordinated manner.

Whereas **IT-ITeS Sector Skills Council NASSCOM (SSC NASSCOM)**, the skill standard setting body of the IT-BPM Industry, is an integral part of NASSCOM in the education & skill development initiative. SSC NASSCOM works with its industry members and assist academic and skill development institutions to help improve the quality and quantity of the employable workforce available to this industry.

NASSCOM/SSC NASSCOM and Guru Nanak College, Budhlada and will hence forth be referred to independently as the ‘First Party’ and ‘Second Party’ respectively and collectively as the ‘Parties’.

THIS MOU WITNESSED AND THE PARTIES HERETO AGREE TO AS FOLLOWS:

A. Objective

This MoU is for collaboration on the conduct of Assessments and Certification on Qualification Packs (QP) and National Occupational Standards (NOS) for Second Party sponsored candidates.

1. The **Objective** of this MoU is to showcase the employability skills of the candidates of the Second Party by their adoption of the National Occupational Standards (NOS), Assessments and Certifications developed by NSDC through its Sector Skill Councils. Under this MoU, First Party will ensure timely completion of assessment & its certification of candidates of the Second Party.
2. Currently 2 QP(s) for which candidates of the Second Party need to be assessed and to be conducted by the Assessment Bodies of the First Party, has been enclosed as **Annexure 1**. Going forward more QPs will be added in consultation with the First Party.

B. Role and Responsibilities of Second Party

The **Second Party** is the implementing organization and will be responsible for activities such as:

1. **Authorisation for Assessment & Certification of Second Party Candidates:** The Second Party will permit the First Party to conduct assessments and certify its candidates as per the defined QP(s), through Assessment Agencies empanelled by the First Party.
2. **Nodal Officer/Coordinator:** The Second Party will designate and recommend a Nodal Officer/Coordinator at Headquarters Level who will be responsible for overseeing/coordinating the program from Second Party which includes MIS & technical operations with the First Party.
3. **Payment Schedule to SSC NASSCOM:** The Second Party shall make 100% advance payment of assessment cost to NASSCOM/SSC NASSCOM i.e. the First Party, for all the batches for which the First Party shall give an acknowledgement of advance payment.
4. Assessment cost shall be paid on the basis of registered/scheduled number of candidates on SSC NASSCOM Portal (this covers those passed, failed and also covers absentees on the day of the assessment) subject to a minimum batch-size, which is 20 candidates per batch. The cost for an assessment and the subsequent certification will be as per the norms of NSDC & NASSCOM/SSC NASSCOM/First Party and currently is at INR. 800/- + all applicable Taxes (Taxes are over and above the assessment cost).
 - a. If a batch is not assessed due to Force Majeure or if informed by the Second Party at least 10 working days in advance to the date of the scheduled assessment or due to any other reason agreed upon by both the Parties, then the assessment will be carried out for the whole batch at a mutually convenient date. This communication between the Parties would be sent via E-Mail.
5. The Second Party agrees to the terms & conditions stated in the malpractice avoidance declaration as detailed in Annexure-II (C)

C. Role & Responsibility of the First Party

1. **Single Point of Contact (SPoC):** The First Party will designate and recommend a SPoC who will be responsible for the overall assessment related activities from the First Party.
2. **Student Assessment and Certification:** The First Party will organize the timely assessment and certification of Second Party candidates through empanelled 'Assessment Agencies' of the First Party. The First Party will issue certificates to the successful candidates via SSC NASSCOM Portal.

3. The First Party will raise an invoice against advance payment post conduct of assessment.
4. The First Party via its Assessment Agency will be responsible for the fair and proper conduct of the QP assessment. Any issue(s) that arise regarding this will be amicably discussed between the First Party and the Second Party and resolved thereof.
5. Candidates will be assessed on the assessment criteria and question banks set by the First Party as per the respective QP concerned.

D. The below given operational processes will be followed for Assessment and Certification:



1. Second Party uploads its batch information in prescribed format on SSC NASSCOM Portal listing all details including the batch end date as required by SSC NASSCOM Portal.
2. Second Party must make the communication/request for the assessment date at least 2 weeks prior the batch assessment /training end date and the assessment date should be minimum 2 weeks post the payment date.
3. The Second Party will transfer the requisite assessment fees via the prescribed Payment Gateway of the First Party, as mentioned in Clause B, Sub clause (3) of this MoU.
4. First Party assigns the batch to its empaneled assessment agency for conduct of assessment.
5. Infrastructure details for conduct of assessment will be shared by the empaneled assessment agency to the Second Party while assessment confirmation is sent via e-mail.
6. On request from First Party the Second Party will furnish the candidate details of batch in excel format. The Second Party will be responsible for the accuracy of all the details provided in the Excel sheet and on SSC NASSCOM Portal.
7. Centre Manager/Centre Head of Second Party will sign a malpractice avoidance declaration form as detailed in Annexure-II (C) on the day of assessment and Second Party will make all efforts to avoid any malpractice at its assessment centres.
8. The First Party will nominate proctors/invigilators to check the credentials of the candidates as detailed in Annexure-II (B) of this MoU.
9. The Second Party will ensure the signing of QP Assessment Attendance Sheet on the day of assessment as detailed in Annexure-II (A) of this MoU.
10. The results of the batches will be declared by the First Party within 10 days of assessment.
11. Certificates will be generated through SSC NASSCOM Portal for successful candidates as per the timelines.

E. Other covenants

1. The use of the name, logo and/or the official emblem of the Parties concerned on any publication, document and/or paper concerning the mission/project under this MoU is permissible, only post approval in writing, as explicit permission from the Party concerned.
2. Any difference or dispute between the Parties concerning the interpretation and/or implementation and/or application of any of the provisions of this MoU shall be settled amicably through mutual consultation or negotiation/s between the Parties, without reference to any third Party. Any other aspects not covered in this MoU, relevant to this program, and disputes etc arising about any aspect of the MoU shall be settled through mutual consultation and MoU, by the Parties to this MoU. In case a settlement is not arrived at, all disputes or differences arising between the parties in relation to the interpretation, meaning or effect of this MoU, or to any breach thereof and remain unresolved after the intervention of the representatives of the parties, shall be referred to arbitration under the aegis of the Indian Council of Arbitration at

3. This MoU will come into effect on the date of digitally signed by both Parties concerned and shall remain valid for a period of one year.
